ORDER

In exercise of the powers vested under section 14(3) (a) of the National Council for Teacher Education (NCTE) Act, 1993, the Western Regional Committee grants recognition to **Saraswati Stri Adhyapan Mandir, Vatera, Ahmedabad** for PTC course from the academic session 2001-2002 with an annual intake of 40 students, subject to fulfilling the following conditions:

1. The institution shall appoint seven teaching staff and supporting staff possessing the qualifications as laid down in the NCTE norms, before the commencement of the academic session 2001-2002 in the salary structure prescribed by the UGC/Central Government/State Government as the case may be.
2. The institution shall shift to its permanent building within a period of one year, if temporarily housed elsewhere.
3. The institution shall ensure library, laboratories and other instructional infrastructure as per NCTE norms.
4. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/State Government.
5. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
6. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the examining body.
7. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
8. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 8 above.

If Saraswati Stri Adhyapan Mandir, P.D. Pandya Mahila College Campus, Vatara, Ahmedabad contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.


Sir,

In continuation to our office order Number 6751 dt. 12 OCT 2001 the following specific conditions/ deficiencies be complied on or before December 2001 --

1. Additional staff be recruited so as to maintain the Teacher - Pupil ratio of 1:12.
2. As per NCTE norms at-least 100 books need to be added every year. Steps be initiated for the same.
3. Additional equipments be purchased for equipping the various labs as per NCTE norms.
4. The institution should maintain an Endowment fund of Rs.5.00 lakhs (Five Lakhs) and an amount equivalent to three months salary of all the staff as Reserve fund in the form of a Fixed Deposit in a nationalised Bank in the name of the Institution/course and the proof of the same be submitted.

The compliance of the above conditions/deficiencies along with the related supporting documents may kindly be submitted to the undersigned on or before December 31, 2001.





2. The State Government is pleased to issue "NO OBJECTION CERTIFICATE" to the above mentioned institutes to start the P.T.C. Colleges from the academic year 2001 subject to the following terms and conditions:-

- (1) No financial assistance will be given to this institution by the State Government in future.
- (2) The institution will have to provide qualified educational staff and non-educational staff, physical facilities and other relevant facilities as laid down under the N.C.T.E. Act. 1983, by the N.C.T.E., Bhopal.
- (3) The above institutes will have to obtain recognition from NCTE Bhopal for proposed PTC Course before the starting the Institution. The institution should not be started without prior approval of N.C.T.E., Bhopal at any cost.
- (4) The State Government will issue permission to start the PTC Colleges only after obtaining the recognition from N.C.T.E., Bhopal to the institution.

- (5) The admission for P.T.C.Course will be given by the Office of Director of Primary Education strictly under the centralised admission scheme of the State Government on merit basis only.
- (6) The institutions will have to implement and observe rules and regulations/the terms and conditions prescribed by the State Government and N.C.T.E. from time to time.
- (7) The institutions will have to complete all the physical facilities including hostel facilities before starting the PTC Colleges as per the N.C.T.E. Norms and report the State Government.
- (8) The institutions will not demand for the change of medium of P.T.C. Course at any cost in future.
- (9) The institutions will not demand for change of place for PTC Colleges at any cost in future.
- (10) A sum of Rs.10/- lacs (Rupees Ten lacs only) in the name of the trust shall have to be deposited by the Trust in the Nationalised Bank for Six Years.
- (11) P.T.C. Colleges should be started with the capacity of 40 (Forty) students with One Class.
- (12) The structure of fees will be as per Norms, Act, Rules, Regulations and Guidelines prescribed by the State Govt./NCTE, Bhopal.



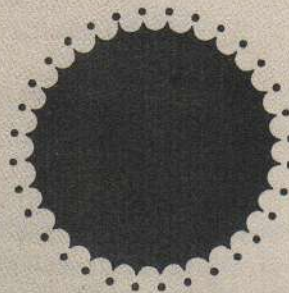


